Dear Ambassador Mr	

This letter ultimately serves to inform your office about the quest for freedom through secession (also referred to as a two-state solution) for the groups of people as represented in majority within the designated secession area of South Africa (herein after referred to as "our people"), and followed since 2014 by the non-political, civil rights organization, the United Liberty Alliance (ULA), and specifically the position it now had to adopt within the current political climate. This letter also serves as part of International Law, that requires the secession movement to communicate its intention and plans to the International Community.

As you would fully understand, the current situation in South Africa is extremely volatile, and in a state of revolution mainly exacerbated by the reaction of supporters opposed to the former President, Mr. Jacob Zuma being investigated for corruption, fraud, racketeering and money laundering. In early July 2021 serious violence erupted with widespread destruction of property and infrastructure when these rioting groups caused damages estimated at around ZAR20Bn (US\$1,5Bn), risking around 150 000 jobs and affecting some 40 000 formal businesses in KwaZulu Natal alone, the worst hit province. The province of Gauteng was widely affected, and several other regions to a lesser degree.

Despite being forewarned of these protests, the ANC government of South Africa, again dismally failed its citizens by not safeguarding the residents, their property and infrastructure. Looting mobs were basically left to freely continue on their paths of sheer destruction without meaningful interference from law enforcement. It was only after the rioting had stopped and most of the larger businesses already destroyed, that the government deployed the SANDF.

The current politically unstable situation in South Africa holds a direct underlying threat for our people, as was clearly indicated during the recent incidents of violence and looting. Against the backdrop of organizations like the political party the EFF and BLF continuously and openly inciting acts of violence against our people, and chants like "Kill the Boer" or "One Indian, one bullet" becoming slogans of these racist leaders and their followers, the potential effects of these irresponsible acts are ominous, especially in the case should the revolution lead to the eruption of a civil war, which, according to several analysts, carries a high probability.

The characteristic signs of this imminent element of danger were experienced during these riots where 342 people reportedly lost their lives, because of the clashes between black



rioting, looting mobs and the Indian citizens were forced (by a total lack of police protection) to protect their communities, properties, and lives.

Measuring the government's previous inaction there remains little confidence that they will act to prevent or quell a civil war should it occur, whose effects could potentially see the advent of vast life-threatening conditions for 'our people', who (even though they are in majority in the area earmarked for secession) represent only about 17% of the entire population of South Africa.

In terms of International law, the United Liberty Alliance reserves the right to call a Unilateral Declaration of Independence (UDI), based on the "De Jure" process, meticulously followed thus far, should a civil war erupt.

We respectfully request that your office and Government kindly take cognizance of the fact that the United Liberty Alliance (ULA) herewith states that it will do everything within its legal capability to safeguard 'our people'.
